What is this product?

Type	The Company is a closed-ended investment company, trading on the Main Market of the London Stock Exchange (within the Premium segment). The Company's Ordinary shares are therefore available to the general public.
Strategy	<p>The Company will be managed with the intention of realising all remaining assets in the Ordinary Portfolio in a prudent manner consistent with the principles of good investment management and with a view to returning cash to Ordinary Shareholders in an orderly manner.</p> <p>The Company will pursue the investment objective of the Ordinary Share Class by effecting an orderly realisation of the assets of the Ordinary Share Class in a manner that seeks to achieve a balance between maximising the value received from those assets and making timely returns of capital to Ordinary Shareholders. This process might include sales of individual assets, mainly structured as loans and leases, or running off the Ordinary Portfolio in accordance with the existing terms of the assets, or a combination of both.</p>
Intended investor	The Company is designed for investors who are seeking exposure to asset finance investments and who are capable themselves of evaluating the merits and risks of the investment or other investors who have been professionally advised, and who have sufficient resources both to invest in potentially illiquid securities and be able to bear any losses (which may equal the whole amount invested) that may result from the investment.
Bid/Offer spread	Shares of the Company are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share may be higher than the price at which you could sell it.
Maturity	The Company entered a Managed Wind-Down on 4 December 2020. The Company is unlikely to be able to realise the full value of its Portfolio and return the proceeds to Shareholders for at least a period of between two and four years, and possibly longer, given the illiquid nature of the product's investments.

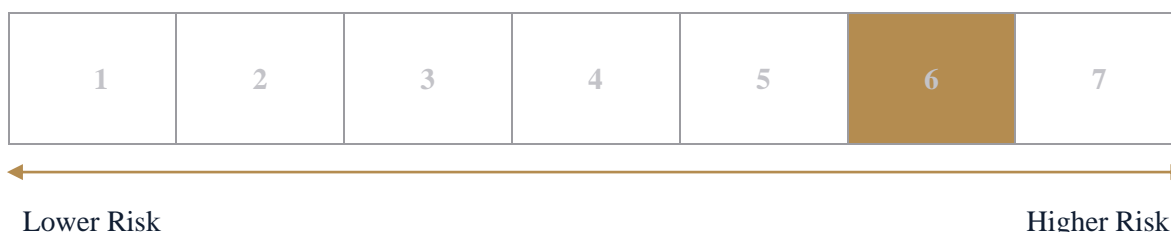

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this fund compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact our capacity to pay you.



The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at any early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The Company is exposed to exchange rate volatility, as it holds assets denominated in multiple currencies. Capital may be at risk as the value of investments may go down as well as up and is not guaranteed.

In a Managed Wind-Down, the value of the Portfolio will be reduced as investments are realised and concentrated in fewer holdings, and the mix of asset exposure will be affected accordingly.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 3 years.

This product has no required minimum holding period but is designed for medium to long term investment; you should be prepared to stay invested for at least 3 years. The Company has entered into a Managed Wind-Down and is unlikely to be able to realise the full value of its Portfolio and return the proceeds to Shareholders for at least a period of between two and four years, and possibly longer, given the illiquid nature of the product's investments.

The value of the Ordinary Shares and the income derived from them (if any) may go down as well as up. Although the Ordinary Shares are traded on the Main Market, it is possible that there may not be a liquid market in the shares and investors may have difficulty selling them. Accordingly, investors may be unable to realise their shares at the quoted market price (or at the prevailing net asset value per share), or at all. You may sell your investment within the recommended holding period without penalty.
